The areas of cooperation include, subject to mutual consent, any Programme offered at either institution as felt desirable and feasible on either side and that


both sides feel can contribute to the fostering and development of the cooperative relationships between the two institutions.



## 2. Obligations:

"All written and oral information, in whatever medium or form, shall be held in strict confidence by all parties and be used only for purposes of this Agreement. Except as required by law; no such information, including the provisions of this Agreement, shall be disclosed by the recipient without the prior written consent of the other party. If either party is required to disclose any confidential information of the other party; the party so required shall notify the other party immediately and shall co-operate in seeking a reasonable protective order."



6. The Institution & the students shall adhere to the guidelines prescribed by the school authorities & AGASTYA FOUNDATION.
7. Encourage students to join AGASTYA FOUNDATION and give them permission to attend events and classes during the week days.

Each Party hereby agrees to defend, indemnify, and hold harmless the other Party and/or its affiliates against any liability, losses, damages or costs (including any legal costs) incurred or suffered by a Party as a result of any breach, negligent act or omission, or willful default on the part of the other Party and/or its affiliates arising either directly or indirectly from the performance (or non-performance) of this MoU.

**8. Arbitration and Jurisdiction:**




**9. MOU Effective Date**
